- It is my intention to maintain my permanent residence in the state of Iowa. Based on this statement and by submitting these documents, I request reclassification to Iowa resident status for tuition purposes.
- I understand that if reclassification is granted, it will be effective the **next term in which I enroll and may not be made retroactive to earlier terms.**
- I have included the correct proof of residency documents required for my situation.

SECTION 1 – Proof of Residency Documents Accepted

Provide at least **TWO documents** from this list. Make sure they:

- ✓ Are dated earlier than the **90 Days Before Semester** date
- ✓ Both are addressed to you, or issued to you, and show your name
- ✓ Both meet all requirements listed below

Mark which two proof of residency documents you're providing:

- Iowa driver's license, not expired Iowa vehicle registration, not expired
- Iowa state income tax return filed for the most recent tax year, signed and dated or accompanied by evidence that it was accepted by the Iowa Department of Revenue
- Iowa voter registration card
- Employer pay stubs covering the three months prior to your first semester
- Written and notarized documentation from an employer that you have been employed in Iowa for at least 90 days prior to the start of your first semester
- Proof of Iowa homestead credit on property taxes
- Lease agreement, signed and dated, not expired
- Utility bill (electric, natural gas, water/sewer, or trash service at your Iowa residence)
- Bank statement

If you are a refugee or asylum grantee, or if your current residency status is International, also provide one of the following:

- A copy of your U.S. certificate of naturalization
- A copy of your USCIS form I-551 permanent resident card (green card)
- A copy of your I-94 card showing political asylum, refugee, or other appropriate status

SECTION 2 – Qualifying Reasons for Residency Status Change

Select one of these ways you may establish yourself as a permanent resident of Iowa for the purpose of tuition at Kirkwood:

- I was granted resident status at an Iowa public university (University of Iowa, Iowa State University, University of Northern Iowa)
 - In addition to two proof of residency documents from Section 1, provide a screenshot showing your approval as an Iowa resident from your student portal, your university bill, or your university ID for us to use to verify your status with the university.
- I have earned a Kirkwood degree, credit diploma, or credit certificate
 - Program/Major: _____
 - Provide two proof of residency documents from Section 1
- I am a returning student and have not enrolled in a college or university for at least three years
 - Provide two proof of residency documents from Section 1
- I originally came to Iowa to attend college but am no longer in college, have remained in Iowa for at least one year, filed an Iowa income tax return in the most recent year, and have been employed at least 90 days prior to enrollment
 - Provide your Iowa state income tax return for the most recent tax year (signed and dated or accompanied by evidence that it was accepted by the state of Iowa) **AND** employer pay stubs covering the three months prior to the term for which you're making the request

- I am a new citizen or new permanent resident of the United States
 - Provide your Certificate of Naturalization OR USCIS form I-551 permanent resident card (green card) and two proof of residency documents from Section 1
- I am a graduate of an Iowa high school
 - Provide your official high school transcript and two proof of residency documents from Section 1
- I made a mistake on my application that resulted in the wrong residency status
 - Provide two proof of residency documents from Section 1 dated at least 90 days prior to your first semester

Bring this form and your supporting documents to Enrollment Services, 3rd floor Iowa Hall, on Main Campus, or to the Welcome Desk in Iowa City.

Note: Due to the level of personally identifiable information contained in some forms of supporting documentation, this request form and supporting documents **should not be emailed**. They should be delivered personally by the student or by the U.S. mail.

Once the form and supporting documents are received by Enrollment Services, please allow 7 to 10 business days for review. We may need additional documentation before making our decision. If we need additional documentation or we have made our decision whether to approve or deny the request, you will be notified by your Kirkwood student email address.
